Newfoundland and Labrador Athletics Association (NLAA) is the governing body for cross country running, road running, and track and field in the province of Newfoundland and Labrador. Only full members are allowed to participate in the numerous sanctioned events across the province. However, in some events non-members may compete, provided that they purchase a **One Day Event Permit**. The cost of the **One Day Event Permit** is \$5 (\$1 for pupils participating at designated school competitions). The One Day Permit is:

- ◆ Valid for only one event only
- ◆ Does not entitle the Applicant to any of the Association's funding, Team Selection or benefits otherwise available to full members

The One Day Permit can be applied for at the NLAA office or will be available at meets at the discretion of the Meet Director. Please forward race/meet fee to the address above.
